- Participants must be present and on time for all practice sessions and games. In addition participant must make every effort to stay for the entire practice session and game.
- Participants are responsible for bringing all necessary equipment to the practice or game field. No football player will be allowed on the field without the proper equipment.
- Participants will address their coaches as "Coach -Last Name" or Coach.
- Participants will not practice until their coach arrives on the practice field. No roughhousing or unsupervised practice will be allowed
- Participants will not intimate or "pick on" other participants.
- Using profane language is prohibited at all times.
- No unsportsmanlike conduct will be tolerated.
- Participants will wear only their practice uniforms to practices and their game uniforms at games.
- Participants will support and participate in all fundraising activities as presented by the Association.
- I solemnly pledge that I will not in any way damage or deface any property, building or equipment.
- I agree that I will remain a member of the team until properly released.
- I agree to return, upon request, the uniform and other equipment issued to me in the same condition as when received except for normal wear and tear
